## WATER REPORT – November 7, 2023

The reservoir system currently holds approximately 1,308,000 AF more storage than it held last year and is 49% full compared to only being 18% full on this date last year.

The Lake Walcott (1909) storage account has already received 100% accrual to its storage right. The Jackson Lake (1906), Henrys Lake (1917), Island Park (1921), Palisades Winter-Water-Savings (1921), and American Falls Reservoir (1921) storage accounts are currently accruing new storage to their water right volumes to be allocated next year.

It will take most of the winter and perhaps a portion of this upcoming spring for the American Falls (1921) storage right to accrue 100% fill to its volume. Once the American Falls 1921-priority space has accrued 100% of its water right volume, the Island Park (1935), Grassy Lake (1936), Palisades (1939), and perhaps the Ririe Reservoir (1969) storage rights will come into priority and begin accruing storage towards their 2024 storage allocations.

All canal diversions above American Falls should have ceased before today unless they have in-priority decreed stock water rights, in-priority decreed subirrigation water rights, or they have leased Rental Pool storage allowing them to divert water in November.

The IDWR computer system is currently unable to process today's water right accounting. Hopefully, the problem will be resolved soon. The water right accounting and historical database will be updated to the webpage after the problem has been diagnosed and fixed.


