Water District 1 Report – May 12th, 2025

Snowmelt has accelerated due to sustained warm temperatures. Natural flow is increasing as we approach peak runoff season, which typically occurs from late May through early June. Irrigation demand has stabilized with most operations now active. Natural flow has surpassed diversion demand, resulting in rising system contents and renewed priority of reservoir storage rights. This elevated priority for reservoir storage will remain as long as natural flow exceeds irrigation demanda condition that may persist for several weeks.

The current deliverable water right priority for irrigation diversions across all reaches is 1939-07-28.

Although peak snowpack was near the median, rapid melt has driven remaining snow levels below normal. As of today:

- Snake River above Heise is at 73% of median snow water equivalent (SWE)
- Henrys Fork–Teton is at 67%
- Willow–Blackfoot–Portneuf is at 29%

The Northwest River Forecast Center projects inflows to the Snake River above Heise at 96% of average.


From this point forward, the system is likely in fill mode, and the probability of another Milner Spill occurring this year is low. Storage rights for Island Park and Palisades may take another 2–4 weeks to fill, with Ririe Reservoir's 1969 right coming into priority thereafter. Storage rights for Lake Walcott, American Falls, Jackson Lake, and Winter Water Savings Accounts for American Falls and Palisades have already filled.

Canal managers should notify the Bureau of Reclamation or Water District 1 at (208) 525-7161 of any significant anticipated changes to diversion rates. Proactive communication helps ensure efficient system operations and supports optimal reservoir filling.




